Common Reasons to Dispute an Orbitz Charge

Customers typically dispute Orbitz charges for the following reasons:

1 Unauthorized or Fraudulent Charges

2 Canceled Booking but No Refund

If a hotel, airline, or car rental provider failed to deliver the service (for example, the hotel was closed or the flight was canceled without rebooking), you may be eligible for a refund

5 Misleading Booking Details

If the actual service significantly differs from what was advertised (wrong room type, hidden fees, missing amenities), you can raise a complaint and request a charge review

How the Orbitz Dispute Process Works

Initial Contact

Investigation With the Vendor

Orbitz will open an investigation with the airline, hotel, or rental company to confirm the claim

Temporary Credit (If Applicable)

Resolution or Denial
